Circular

**Subject :- "Earned Salary/Pension Advance Drawls Access Scheme (1 month)"
and "Advance against 3 & upto 24 Months Salary/Pension Scheme"**

Reference :- (i) Circular No. F.6 (2)FD/GF&AR/2022 dated 31.05.2023 of FD (G&T).
(ii) Circular No. F.10 (7)FD/Pension/2022 dated 08-07-2024 FD (Pension).

The Government of Rajasthan issued circulars to facilitate its employees and pensioners to access drawls to a line of credit through empaneled Service Providers and Financial Institutions (Banks / NBFCs) with RFSDL corresponding to their salary / pension for the purpose to provide seamless liquidity. The facilitation is being provided at IFMS 3.0 & mobile applications of Financial Institutions and Service Providers as per Digital Lending Guidelines of RBI.

Important aspects and parameters of the scheme are as under :-

- (i) RFSDL is the Nodal Agency of Finance Department for the above scheme and shall coordinate, facilitate and monitor the scheme regularly.
- (ii) Scheme will be operated on digital mode only and IFMS wing will carry out necessary implementation including any changes in the platform exclusively as per FD / RFSDL orders / circulars / letters.
- (iii) Advance will be maximum upto 50% of the net salary / pension of the concerned category (1 month / 3 months / upto 24 Months). Employee can take multiple drawls / advances in a month according to the upper capping of earned net payable salary / pension. However no two advances can be outstanding at the same time.
- (iv) Recovery of advance will be through the EMIs in the coming month/s, but if the advance is drawn after the 21st of the month, the recovery will be started from the next month's salary.
- (v) Transaction fee / interest chargeable for the advance are displayed at IFMS 3.0 and/or mobile app of Financial Institutions / Service Provider. Before applying for an advance by any beneficiary, it will be mandatory to show the Key Facts Statement (KFS) which includes chargeable transaction fee / interest as per RBI's regulation and guidelines.
- (vi) Chargeable interest shall be clearly agreed upon between borrower and lender before loan sanction and shall be driven by anti-usury guidelines prescribed by RBI. But it should not be more than 24% of APR (Annual percentage rate calculated as per RBI's KFS guidelines including interest, all fees, credit protection and Stamp duty) calculated on a reducing balance.
- (vii) No charges will be levied in case of foreclosure of advance at any time / stage.



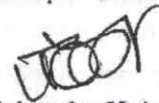
- (viii) In case of non-recovery / defaults in re-payment, sole responsibility lies with the Financial Institution / Service Provider. No assistance will be provided by Govt. of Rajasthan / RFSDL / IFMS in such cases. The Government/RFSDL is in the sole capacity of a facilitator and the loan agreement is between the lender and borrower.
- (ix) In the case of the 24 Months program, the repayment tenure may be extended up to 36 months but with the same advance amount limit of 50% of net salary/pension of 24 months.
- (x) There will be no Foreclosure charges.
- (xi) The deduction of EMI should be shown in salary slip as well as in LPC in case of transfer.
